

INVITATION FOR EXPRESSION OF INTEREST (EOI)

Procuring Entity: Climate Action Network (CAN) Tanzania

Tender Description: Supply of Equipment – Gebe Procurement Process

A. INVITATION AND BACKGROUND

The Climate Action Network Tanzania (CANTZ), herein referred to as the Procuring Entity, invites eligible, qualified, and competent suppliers to submit Expressions of Interest (EOI) for the supply of specialized equipment.

This procurement process is conducted in accordance with the principles of public procurement as guided by the Public Procurement Act of Tanzania and Policies of CAN TZ, that including transparency, competition, fairness, accountability, and value for money.

The purpose of this EOI is to shortlist capable suppliers who will be invited to participate in the subsequent procurement process in accordance with the Terms of Reference (TOR).

B. SCOPE OF PROCUREMENT (LOTS)

Interested applicants may express interest in one or more of the following lots by specifying on the EoI letter subject line:

Lot 1: Electric outboard motors and related accessories

Lot 2: Equipment for analysis of environmental status

Lot 3: Electronic fuel monitors

The successful supplier(s) shall be required to supply goods in accordance with the technical specifications, quality standards, delivery requirements, and conditions of contract as detailed in the TOR.

C. ELIGIBILITY AND QUALIFICATION REQUIREMENTS

To be eligible for consideration, applicants must demonstrate that they meet the following minimum qualification requirements:

1. **Valid Business Registration:** A valid Certificate of Incorporation, Business Registration Certificate, or equivalent legal registration document issued by an authorised authority.
2. **Tax Compliance:** A valid Tax Clearance Certificate and VAT Registration Certificate or equivalent tax compliance documentation issued by the relevant tax authority.
3. **Company Profile:** A brief company profile including physical address, telephone contacts, email address, and a description of the organization's core business activities.
4. **Relevant Experience:** Demonstrated relevant experience in similar assignments (For either Lot 1, 2 or 3) for at least three (3) years.
5. **Client References:** A list of at least three (3) major clients for similar supplies or services, including contactable references.
6. **Technical Capacity:** Evidence of adequate technical capacity, resources, and capability to perform the contract.
7. **Quality Assurance:** Evidence of quality assurance certification (such as ISO or equivalent standards).

Applicants shall submit his/her interest with a maximum of two pages and be evaluated based on their eligibility, experience, technical capacity, and ability to perform the contract.

Only applicants who meet the qualification requirements shall be shortlisted and notified by email for the next stage of the procurement process.

D. REQUEST FOR DOCUMENTS

Interested suppliers may obtain the Terms of Reference (TOR) and detailed application procedures by submitting a written request via email to: venture@cantz.or.tz, wande@cantz.or.tz and martha@cantz.or.tz

The TOR will provide detailed instructions regarding submission requirements and evaluation procedures.

Applications must be prepared and submitted in accordance with the requirements specified in the TOR.

E. SUBMISSION DEADLINE

Expressions of Interest must be submitted within the period: From 16 March 2026 to 29 March 2026. Late submissions shall not be considered.

F. PROCUREMENT PROCESS

This Expression of Interest constitutes the first stage of the procurement process for supplier identification and shortlisting. Shortlisted applicants may be invited to participate in subsequent procurement proceedings, which may include request quotations, competitive tendering, or other procurement methods as determined by the Procuring Committee.

G. DISCLAIMER

The Procuring Committee reserves the right to accept or reject any Expression of Interest, to cancel or terminate the procurement proceedings at any stage, and to reject all applications without incurring any liability to applicants, in accordance with applicable procurement regulations.

Participation in this EOI process shall not create any contractual relationship between CAN TZ and the applicant. All costs associated with preparation and submission of the Expression of Interest shall be borne solely by the applicant.

Eligible suppliers are encouraged to apply within the specified timeframe.
